

Momentive Specialty Chemicals' Oilfield Technology Group Expands Triazine Production Plant

HOUSTON, Texas - (October 22, 2013) - The Oilfield Technology Group (OTG) of Momentive Specialty Chemicals Inc. ("Momentive Specialty Chemicals" or the "Company") today announced an expansion of its triazine production plant in Diboll, Texas.

Momentive Specialty Chemicals is a leading supplier of triazine products that are used for hydrogen sulfide (H2S) scavenging in crude oil, natural gas, liquefied petroleum gas, and SAGD (steam-assisted gravity drainage).

The Company's triazine production plant in Diboll has gone through a significant amount of upgrades. Phase 1 expansion includes additional new blend tanks designed to perform post reactor blends. The additional capacity provides greater flexibility for manufacturing a wide range of products and allows for shorter lead times and increased storage capacity for finished goods. The expansion also increases the plant's truck loading capability, allowing the Company to easily fulfill large customer orders with shorter lead times.

The plant's phase 2 expansion plan, scheduled to be completed in the fall of 2014, will add another triazine reactor as well as additional raw materials storage and handling. The additional capacity will essentially double production levels. The additions will support production of current MEA/MMA triazines, along with increasing capabilities to blend in various ingredients to the triazines.

Both phases of the plant expansion will continue to drive the growth and development of new finished products for customers as well as basic formulations to be used as blends. It will allow the handling of significantly greater volumes, expand the range of custom blends, and provide the flexibility to quickly adapt to customer requirements.

"Our expanded triazine production allows us to meet the increasing demands of our customers in the Gulf Coast area" said Jerry Borges, Senior Vice President, Oilfield Technology Group. "The plant will also operate more efficiently, ensuring that we continue to provide our customers with some of the most advanced, high quality triazine products in the industry."
